	Education Session: AMHS-KFLA Housing Programs – Realities and Service Considerations	
1.	 S. Preston and J. Lalonde presented on AMHS-KFLA Housing Programs and planning. Highlights of the information shared included: A general overview of AMHS-KFLA's residential properties The role of AMHS as a Landlord and how it relates to clinical supports How the housing realities for clients affect the staff, including the emotional toll due to limited housing resources. AMHS approach to housing to ensure we are proactive in providing low-barrier, supportive housing that fosters recovery and long-term success. Strengthening the clinical lens in how housing supports are delivered and deepening the integration both internally and with external partners. A discussion on the importance of partnerships between AMHS and landlords occurred. These are necessary to support clients living in the community, to promote stability, and enhance clients' success as tenants.

4.	Governance Recommendation Review: Board Size, Composition, and EDI and Recruitment a) Governance Report AMHS KFLA, August 2025 b) AMHS Governance Presentation J. Foster reviewed the Governance Report AMHS-KFLA by Bhavana Varma with the Board. The Board discussed the recommendations outlined in the report and suggested reviewing local demographics to ensure that Board representation reflects the percentage of Black, Indigenous, and other racialized populations in our region, rather than comparing solely to Ontario-wide figures. The Board agreed that the priority should be recruiting additional members to increase the Board's size. This will support succession planning, ensure quorum at meetings, and allow business to proceed if members are unable to attend. To initiate this work, the Board will establish a Recruitment Committee to carry out the recommendations. All members expressed gratitude for the support and advice provided by Bhavana through this process. Moved by E. Leslie, seconded by B. Devlin. 5.	AGM Update B. Dean reviewed the AGM briefing note as distributed in the board meeting package. This document outlined the plan for AMHS-KFLA's 2024/25 AGM to occur on September 24, 2025. Board Members are encouraged to RSVP by email to J. Dupuis.	
6.	CEO Monthly Board Report for August 2025 B. Dean reviewed the CEO Report, which highlighted the Agency's activities, organizational status, progress on strategic and other objectives, and significant risks. Overdose Awareness Day will be recognized on August 31st, with AMHS partnering with KCHC to host an event at the ICH on August 29th, as well as a separate event in Napanee on August 28th. Psychiatry recruitment efforts are ongoing. The Leadership Team has reviewed the results of the Workplace Culture Values and Engagement Survey, and work is underway to share the findings with staff and to develop meaningful activities that will support the creation of the desired workplace culture. The fifth meeting of the ICH Community Engagement Committee was held on August 7. These meetings
